Agricultural Development in AONB, East Sussex

LVIA to support a Planning Appeal against Rother District Council's refusal of planning permission for a new Agricultural Barn in the High Weald AONB near Broad Oak, East Sussex. The appeal was successful and the planning decision was overruled.

Gravesham Strategic Land Availability Assessment

LVIA, Ecological Assessment and Masterplan to support an allocation for residential development in Istead Rise, Kent as part of the Gravesham SLAA process. Descision pending.

Residential Development overlooking AONB, Kent

Paragraph 55 House in Kent Downs AONB, Dover

LVIA to support a planning application for a paragraph 55 house in the grounds of a Grade II* listed manor house. An appeal is scheduled for November 2018.

Townscape Assessment, Sevenoaks, Kent

Townscape and Visual Impact Assessment to support the rebuttal of a Planning Appeal for a new dwelling in Sevenoaks, Kent. The appeal was dismissed.

Townscape Assessment, Bexley, South London
